#### FIRST PART

#### Purpose, Scope, Basis and Definitions

#### Goal

**ARTICLE 1** - (1) The purpose of this Regulation is the opening of private education institutions of all degrees and types. and to regulate its procedures and principles.

#### Scope

**ARTICLE 2** - (1) This Regulation, Private Education Institutions dated 8/2/2007 and numbered 5580. It covers the private education institutions specified in the Law.

#### **Definitions**

ARTICLE 4 - (1) In this Regulation;

#### Interrupting education and training activities upon the request of the founder

#### ARTICLE 9 / B - (Annex: RG-13/1 / 2017-29947)
